












Expert Workshop on

Microplastics in the Water Environment

18 (arrival) - 22 (departure) August 2019, Thailand













Background

Today plastic materials are present in nearly all spheres of modern life, starting from simple packaging, clothes containing synthetic fibers, containers, drinking bottles and tyres to various life-supporting medical equipment. Their manufacture, use and discharge have significantly increased the amount of plastic waste, including plastic marine litter in oceans which is detrimental to the ecosystems and human health. When improperly managed, plastics can make their way into the aquatic environment. Single use plastic makes up approximately 80-85% of the total number of marine litter items, measured through beach counts. Global Plastic Production is raising rapidly. By 2030 the world may produce 619 million tonnes of plastic every year. Marine litter and microplastics are having a great impact on global environment and human health. How to improve reuse and recycling, minimize plastic waste and promote plastic alternatives, have received much attention recently for the purpose of controlling plastic litter in the freshwater and marine ecosystems.

A further threat is not only the size (< 5 mm) or the physical property but also the chemicals and microorganisms bound to the MPs that have toxic impacts on both aquatic and terrestrial species. Not to mention that the toxic impacts can be realized throughout the world via globalization and trading of food. Research related to MPs is at its infant stage and thus is facing a number of un-knowns and incompletely answered questions. Most of known literature studies are concentrated in the Northern hemisphere (Europe, North America, etc.) but very few studies are known in the Southern hemisphere for example, Asia or Africa. In addition, most of the investigations were carried out in marine ecosystem, however, the main source of MP pollution actually originates from terrestrial and freshwater ecosystems. Until today, no reliable inventory of MP pollution of rivers, estuaries, and sediments has been carried out in order to assess the current state and subsequent health risk to human and other living organisms.

Objectives

The objectives of this expert workshop are:

- To provide the participants with state-of-the-art knowledge of microplastic pollution and its related implications;
- To identify and deliberate upon the research needs and concepts against the background of increasing threats to ecosystems, wildlife, and human health.

Topics

The main topics will be:

- Life Cycle Assessment of Plastics
- Distribution, Sources and Abundance of Microplastics
- Monitoring of Microplastics
- Regulation and Management of Plastic Waste and Microplastics
- Political and Environmental Dimension for Prevention of MPs Pollution
- Ecological and Social Impacts/Risks of Microplastics
- Microplastics (e.g. microbeads) in Manufactured Products and Emissions to the Environment
- Knowledge Gaps and Research Priorities about Microplastics
- Removal Technologies for MPs from Aqueous Environment with special focus on Water and Wastewater Treatment Plants
- Analytical Methods for MPs Analysis and Standardization

Expected Outcomes

At the end of the expert workshop, participants will

- Have an improved understanding of microplastic genesis and threatening impact on ecosystem, wildlife and human beings
- Have obtain a holistic view on the microplastic problem and its inherent risk potential and negative impacts
- Have identified potential areas/topics for research on microplastic pollution and standardization in microplastic characterization and analysis
- Network establishment in the field of microplastic research
